**KEY RESPONSIBILITIES FOR THE POST OF FACT CHECKER**

**a) *Digital Media Monitoring:***

- Continuously monitor all major social media platforms (Facebook, Twitter, Instagram and YouTube etc.)
- Track emerging narratives, trends and potential misinformation related to ECP.
- Develop real-time tracking mechanisms for viral content and emerging ECP discourse.
- Identify and categorize potential sources of misinformation.

**b) *Fact-Checking and Verification:***

- Systematically verify claims, statements and narratives circulating on digital platforms.
- Cross-reference information with official sources, electoral data and authenticated records.
- Prepare detailed fact-checking reports with clear evidence and source citations.
- Develop rapid response protocols for addressing electoral misinformation.

**c) *Reporting and Communication:***

- Produce daily and weekly comprehensive reports on digital media trends.
- Prepare immediate alerts for critical misinformation that may impact electoral integrity.
- Collaborate with Spokesperson or PRO to develop strategic rebuttals.
- Maintain a centralized database of verified and disputed claims.
